Our Savior's Lutheran Church Annual Meeting Minutes January 30, 2022

President Jen Linse called the meeting to order at 11:20 AM. There were 31 in attendance.

Agenda: President Linse noted that there were two additions to the agenda – the election of Sugar Creek and Bethany Homes representatives, and a revision of the authorized amount for the tech project. A motion was made and seconded to approve the agenda as amended. Motion carried.

Devotions: Pastor Jean led devotions.

Minutes: President Linse drew attention to the minutes of the June 14, 2021 annual meeting, which were approved by the Congregation Council at its July, 2021 meeting.

Reports: The following reports were noted: Pastors, President and Council, Committees, Financial, and other reports.

 A motion was made and seconded to receive the various reports, as well as accept the 2021 budget report and other financial reports for 2021.
 Motion carried.

Elections: President Linse noted the following nominations in the annual report on p.22, and the additional nominees for Sugar Creek and Bethany Homes on the addendum distributed at the meeting.

- Congregation Council (three-year term four to be elected) Naoko Giblin, Alison Hemker, and Jen Linse
- o Congregation Council (two-year term one to be elected) Michelle Witte
- President Linse asked for nominations from the floor for Congregation Council.
 Jeff Haldeman was nominated for a three-year term.
- Mission Endowment Fund (three-year term two to be elected) Jeff Rich, Melody Schmitz
 - A motion was made and seconded to close nominations for all positions. Motion carried.
 - A motion was made and seconded to elect the five candidates for Congregation Council and two candidates for Mission Endowment Fund as nominated. Motion carried.
- 2022 Synod Assembly voting member (four to be elected for one-year term) President Linse noted that there are no nominations for Assembly voting member. In the absence of nominations from the floor, the Congregation Council will appoint voting members.

- Sugar Creek representatives –Mike Larson, Jeff Haldeman
 - A motion was made and seconded to close nominations for Sugar Creek delegates. Motion carried.
 - A motion was made and seconded to elect the two candidates as nominated. Motion carried.
- Eagle Crest Communities (formerly Bethany Homes) representatives Larry Blunck, Jim Michelson
 - A motion was made and seconded to close nominations for Eagle Crest Communities delegates. Motion carried.
 - A motion was made and seconded to elect the two candidates as nominated. Motion carried.

Nominating Committee – President Linse noted that for the past several years we have used a different process for securing nominations rather than a Nominating Committee. Pastor Jon explained that process, stating it has worked well. There being no nominations for the Nominating Committee, the congregation will use the same process next year.

Unfinished Business – Pastor Jon reported that the tech project is expected to begin the week of May 23 after a long delay due to supply chain issues. As with other areas, costs have risen. In 2021 the Annual Meeting authorized an expenditure not to exceed \$40,000. Dean Olson has requested an additional \$5,000 to complete the work we have planned.

 A motion was made and seconded to increase the authorization for the tech project from \$40,000 to \$45,000. Motion carried.

New Business -

- 2022 Budget President Linse presented the proposed 2022 budget, and asked Pastor Jon to review the budget. Pastor Jon reviewed the 2022 budget proposal and answered questions concerning several budget line items.
 - A motion was made and seconded to adopt the 2022 budget as presented. Motion carried.
- Mission Endowment Fund Resolutions President Linse drew attention to resolutions #2-4, on pp. 42-43, regarding the Mission Endowment Fund, and come to this meeting recommended by the Congregation Council. Pastor Jon explained each of the three resolutions.
 - A motion was made and seconded to adopt Resolution #2, removing undesignated memorials from the third resolved of the Resolution Establishing Our Savior's Lutheran Church Endowment Fund. Motion carried.

- A motion was made and seconded to adopt Resolution #3, amending Section I, Paragraph 7 of the Plan of Operation for the Mission Endowment Fund by changing the amount from \$750,000 to \$1,500,000. Motion carried.
- A motion was made and seconded to adopt Resolution #4, amending Section III, Paragraph 4 of the Plan of Operation of the Mission Endowment Fund to require the annual distribution to be adopted by the Annual Meeting of the congregation. Motion carried.

Expression of Thanks – Pastor Jon expressed the thanks of the pastors for all who have served on councils over the past years, and for those who continue to serve us, and especially for President Linse for her leadership of the council and congregation. He also thanked the many who have continued to share in the work of this congregation and to support our work together.

Adjourn

A motion was made and seconded to adjourn the meeting at 12:40 PM.
 Motion carried.

Pastor Jon closed the meeting with prayer.

Senior Pastor's Report

As I write this report it's cold and rainy. Yes, it's January, it's Wisconsin, and ... it's raining. But not to fear, the weather forecast for 48 hours from now includes "watching a potential winter storm." Not the best weather! Of course, as I have heard people say, "If you don't like our weather, just wait five minutes. It will change!" (Note: they say the same thing in Upper Michigan, Chicago, and Buffalo!) The point is that things are cold, ugly, and depressing. And the only change in the forecast is ... worse!

That is kind of the way things feel these days. We've struggled over the past three years to move out from a pandemic, moving beyond Covid, hoping for things to change. And what do we get? Still Covid, but now the flu and RSV. Moreover, most economists predict a recession coming, political dis-ease remains, and the war in Ukraine isn't going away. And to add insult to injury, the Packers didn't make the playoffs, the Vikings are already out, and Pastor Jean's Bears have the first pick in the upcoming NFL draft because they earned it.

And then it will snow on Wednesday!

Like the view outside my window, there seems to be no hope, no light, and little to be excited about. It's rain and cold and wind ... and a snowy forecast. Yet, despite the view, there are some signs of hope. And it starts (and ends) with "Jesus is Lord and Savior." More on that in a moment.

But first ... 2022 was still "un-normal." The old normal is gone, but the new normal is still not yet evident. The rhythms of life are still changing, and haven't stabilized. In other words, change is still happening! We just don't know yet where we will land. And when we do land, if we will land on our feet! Worship, education, pastoral care, outreach and service, community building within and without the congregation — all have been, and continue to be, impacted by the changing world around us.

Yet, despite all the change, one thing has not changed. "Jesus is Lord and Savior." Again, more on that in a moment.

So, what did 2022 mean for us? Maybe ... the future?

GUIDING PRINCIPLES

Way back in 2021 we gathered a small team, a "think tank" of sorts, to ponder life and the world ... and ministry. What might God be calling us to be and to do? And in light of God's call, what makes us "us?" Through prayer, scripture, and sharing we began to discern our "guiding principles." A "guiding principle" is something that defines who we are, or at least what we want to be. To put it another way, if you are going to know Our Savior's, you have to know our guiding principles. They are sort of our "DNA" as a community seeking to be faithful to God's calling.

The list of our "guiding principles," by definition, begins with "Jesus is Lord and Savior." All we are, all that we value, flows out of this affirmation. It's the heart of who we are as disciples of ... guess who? Jesus!

The rest of our principles reflect who and what we believe God wants us to be. Welcoming ... difference makers ... care for the world around us, both people and creation ... the value of being together ...

After developing an initial draft, we then brought the conversation to the Congregation Council. Over several months of conversation and reflection, we revised and refined our understanding of who we are to be.

- 1. Jesus is Lord and Savior. (I told you it would come up again!)
- 2. All are welcome, and we are intentional about that welcome.
- 3. God gifts and calls every one of every age to be a difference maker in the world.
- 4. We treasure the gift of creation and embrace the call to protect God's world.
- 5. We value the gathering of God's people in worship and all our ministries.
- 6. We seek the guidance of the Holy Spirit in a world that has changed dramatically.

But, now what? Now, we use these "guiding principles" as a measure of our work and our ministry. Sort of a yardstick to make sure we are staying faithful to what we discern God is calling us to be, with the understanding that perhaps in time, we will discern new guiding principles. But for now, this is where we are!

So, take a peek and see what you think. Do you see Our Savior's in that list? Can you see our life and ministries reflecting those principles? Can you imagine new ways to live out what God is calling us to be?

We've started to share a bit about each of these in the newsletter, so watch for more in the coming months. All essential to who we discern we are called to be as people of God and a community of faith.

2022, however, was more than just defining who we think we are called to be. It was also filled with the ministry we carried out, even in a changing and challenging world.

WORSHIP

Worship returned to a full, in-building experience as the year unfolded. The liturgy was gradually reintroduced, the choir and handbells resumed, and the SOS Band brought energy to our worship experience. In-building worship numbers are at about 55% of pre-pandemic levels, while online worship (harder to count – we have to estimate) adds another 40%, putting us close to where we were in 2019. While we would love to return to a "full house," the ELCA Bishops had been warned to expect a 15-20% drop in attendance due to the pandemic, so these numbers are not unexpected. Moreover, we need to be understanding of those for whom in-building does not work right now, and celebrate that there are other ways they can join in the worship experience.

We also have a number of new individuals and families. Some have joined the congregation, while others have been regular worshipers with us. Always exciting to

welcome new folk in our midst! Meanwhile, we look forward to welcoming back (when they are ready) those who have not been comfortable yet joining us in the building.

A piece of unfinished business was the retirement of Kathy Brisson as our Assistant Worship Musician. Kathy retired as the pandemic began, but we weren't able to honor her as we wanted, so ... we honored Kathy's many years of work in a variety of roles in late November. As we said then, we say again now – *thank you, Kathy!*

EDUCATION

Confirmation classes continued with some tweaks in how we operate, but still focusing on the Bible, catechism, and servant leadership. Check out the page elsewhere in the annual report. Adult Bible study also continues, and Pastor Jean and I continue to ponder new ways to share Bible, faith, and life in a very busy and changing world.

PASTORAL CARE

Pastoral care means a lot of things – weddings, funerals, baptisms, homebound visits, hospital calls, and just general conversation – all part of the "pastoral care" ministry of the church, and of the pastors.

2022 was a bit of a mixed bag. Weddings were few, though that continues a trend that began several years ago. That trend includes more weddings held outdoors or at venues. On the other hand, it was a busy year for funerals. Most of the funerals were not members, but had connections to Our Savior's. That's part of our ministry!

Hospital calling is much reduced from years past, but that too is both a trend and result of Covid conditions. Please let us know when you are hospitalized and desire a visit. It is harder to get that information from the hospital, and with stays shorter than they once were, our window to visit is pretty small!

We continue to visit homebound folk, with more frequent visits as Covid conditions improved over the year. We have also continued, when we are able, our worship at the care facilities in West Salem. Occasionally those services are canceled, but always by the facility due to a Covid outbreak in their building. Finally, we are looking to renew our "Home Communion Ministry" in early 2023. Thank you to all who have been a part of that ministry in the past, and all who will continue to connect and share in the future.

STEWARDSHIP

First of all, **thank you!** Thank you to all of you who have been so faithful in supporting the work we do together. We really do make a difference. Lives are changed because of the work we do together. Some of those lives are here, in our own backyard, and others are literally around the world!

The good news is that we ended 2022 with only a small deficit, and a very healthy general fund balance. However, with the pressures of inflation, and the continued

renewal of our ministries, our budget needs for 2023 are almost 10% higher. We will need to continue to work on our stewardship as 2023 unfolds. Still, over the almost 170 years Our Savior's has been around, God has always challenged us, blessed us, and empowered us through the Holy Spirit. So, our budget is a bit of a challenge – but we have God's calling and God's gifts ... and remember ... Jesus is Lord and Savior.

OUTREACH

I hate to say only a brief word about outreach, because it is so vital to who we are, but there are reports elsewhere on these ministries. Just know that I treasure the many ways we seek to "reach out" in our outreach ministries. Ways like ... Mission Support, Quilting group and prayer shawl ministry, Feed Our Children, Norwegian Dinner (where all the proceeds go to ministries and programs outside the congregation that meet the needs of people), Mission Endowment Fund distribution (\$18,300 proposed for 2023, with over 70% going to support missions and ministries outside the congregation), Corn Roast, World Hunger Appeal, Care and Share Food Pantry, and more!

Meanwhile, through our mission support of the La Crosse Area Synod and the ELCA we work together in our outreach across the area, the country and the world. And then ... in our support of Sugar Creek Bible Camp and LuMin (campus ministry) we change the lives of young people right here in our area.

COMMUNITY

Over the past year we have held a variety of conversations about the future and what are we called to do and to be. For the congregation, for the community around, for our youth ministry – just what is the big need? The answer kept coming back to community and relationships. One of our tasks in the coming year is to find new ways to connect with each other. That doesn't mean "rewinding the tape" and doing what we have always done, nor does it mean suggesting that everyone else ought to do and like what I do. It means meeting people where they are at, and discovering new connections that work for them. How? I don't know. Not yet, anyway, but that's something we will be praying about over the next few months.

BUILDING ISSUES

2022 was supposed to bring new tech in worship. Didn't happen! After a series of disappointments (but no money spent), we had to pivot to a new provider. We are now much further along in the project, and we expect the new tech will be in place by spring. Live-stream worship, projection capabilities, a new audio system, and more. Yes, there is a cost, but it will be a huge benefit to our ministry.

There are also some other building and facility needs. A new roof, the parking lot surfaced, and some other upkeep projects are in our future. We will be working with an engineer to get the appropriate recommendations and cost estimates early in 2023. Remember that many years ago faithful folk put forth the resources to leave us a building. Our turn to invest in the future of God's work here at Our Savior's!

FINALLY

After all that ... what else is there to say ... but thank you? So ...

- **Thank you** to all of you as we have been drawn together in a community of faith, called to work together, and blessed with each other! Thank you for your support and partnership over the past year ... and years.
- **Thank you** to the community of West Salem, Bangor, La Crosse County ... and beyond ... around us. Why? First, because our ministries receive generous support from the community. But also, without the community we have little purpose. It is essential for us to be grounded in our community and it's needs. So, thank you to the community for your support ... and for the opportunities you give us to be servants and disciples of Jesus!
- Thank you to all who have shared in leadership ... members of the
 Congregation Council and especially Jen Linse, our president. But also, to all
 who in less visible ways have helped lead, shape, and nurture our life and work
 together. Your sharing of time and energy is a gift and to you and to God, I
 give thanks!
- **Thank you** to our staff who work hard for the gospel, and work well together! Jill (treasurer) and Karen (financial secretary) keep our finances in order, Josh (custodian) keeps our building in shape, Linda (music director and lead musician) and Laurie (handbells and assistant musician) keep us singing and humming, Eric (choir director) leads our "messengers of music," Tony (after school dishwasher), and Elliott (keeps the lawn mowed!) all valued partners in our work together. And then a *special thanks* to Kris our administrative assistant, who keeps our office in order and our work in line! Thank you to all of you!
- **Thank you** to Pastor Jean and to Rebecca! Yes, Pastor Jean is my colleague, and I rely on her for so very much. The work she does, the sounding board she provides, her presence ... But also Rebecca, who gives me the space to be me, and to be what God has called me to be. Thank you both for all you share!
- And finally, thank you to a good and gracious God, and yes ... to Jesus (who) is Lord and Savior! Gifted and empowered by God, we live out our baptism in our discipleship. Do you wonder what the purpose of life is? This is it and it just doesn't get any better than this, to be what God has created us to be, to be faithful in all that we do, and to know that, in the end, God has our back!

2022 had its challenges ... 2023 will have even more challenges. But we are the people of God, gathered together in this place, for this time, to embrace the tasks God places before us. Thanks be to God!

Associate Pastor's Report

The beginning of 2022 seems like so long ago, a distant memory ... maybe it's hysterical amnesia, maybe so many things have changed so many times it's hard to keep up ...

The year began with access to the building still limited, but by the end of the year we were back to some semblance of "normal" – or at least our new normal moving forward. The transition was probably more gradual for most people, but for me it was abrupt and jarring. Having been on sabbatical this summer, transitioning out with not a lot of people around in May, and coming back to all of the hustle and bustle of fall scheduling, took some getting used to, and at times was even a bit overwhelming.

Last winter and early spring, some ministries were cautiously added back, but still with restrictions. The Sunday School classes were split so only half of the students were in the building each week. But even with the crazy schedule, it was good to have the kids back. And, it was even better in the fall when we resumed the regular schedule with everyone here together. Having the kids together in the building is life giving – all of their energy, enthusiasm, and love shines brightly. The fall brought challenges with getting teachers and music leaders, but one thing we learned from the pandemic was to be flexible and willing to change, and that is what we did ... some classes were combined, teachers committed to being here every week (our teachers are the BEST!!), parents and others stepped up to be substitutes to give the teachers a break (THANK YOU!!), and we did without music except for the Christmas program.

As we began to worship with more people coming back to the building, there were (and still are) those who were not comfortable. Our virtual presence – YouTube and Zoom – is still an important part of worship and continues to be a high priority. We had high hopes of having our tech project up and running earlier in the year to provide a livestream option for worship as well. Due to circumstances beyond our control, we had to start all over this summer, including engaging a new company to provide this service for us. We thank Dean Olson for his patience, diligence, persistence, and knowledge as he quarterbacks this project. We also thank the congregation for staying with us on this, and for your continued financial support of this project. I can't wait until it's done and to be able to take advantage of the new technology!

During the summer I was able to take my long-awaited sabbatical that was to happen in 2020. Timing is everything and my timing wasn't so great for Pastor Jon. He had the busiest summer in his 37 years of ministry and I wasn't here to help out. But selfishly, my time re-connecting with those from my past was renewing, life-giving, and needed more than I ever imagined. I traveled to Iowa to visit with a seminary classmate and spend time in Amana, where I had visited with my family as a child; back to Iowa to meet up with my cousin from Missouri and get caught up with all things family; up to the Upper Peninsula to catch up with friends that I have missed from our congregations and synod work; back home to Chicago to meet up with my college roommate, a friend from Sunday School days, a friend from kindergarten, church friends, and family; and finally to Lake Geneva for a "girl's weekend" and to attend an evening "class" at the Lake Geneva School of Cooking where we prepared and consumed a four-course gourmet meal and wine pairings, in the midst of laughter and memories. A highlight

when I was in Chicago was attending my home congregation and being able to preside at Holy Communion on the spur of the moment ... it's a long story, ask me about it! Thank you for allowing me this time of renewal and sabbath.

In addition to reconnecting with the people of the past, was reconnecting with something I used to love to do ... cook. Rebecca and I were supposed to make dinner twice a week while I was off, but best laid plans ... We were able to plan, prepare for, and make several meals – all new recipes – which meant Pastor Jon had to "try" new things, and he was a good sport, claiming to like most of them.

In order to invite the congregation to be a part of the reconnecting, I decided to create a cookbook using recipes from congregation members, as well as the family and friends I reconnected with on my trips. We got off to a slow start, but I ended up with 313 recipes! It was more of a project than I had expected, doing everything by myself – typing, editing, proofreading, designing, deadlines – but I had fun reading the recipes and the stories that went along with them ... and there were some pretty great stories!! Thank you to my "publicity agent", Brenda Skittone, for selling the books before and after most worship services this fall; and to Kris Seeger for collecting recipes and selling books during the week. When all have been sold, we will be sharing \$2,000+ for the roof fund. (There are still some left, if you haven't gotten yours!)

To get people reconnected with various ministries that they were involved with prepandemic, we went back to assigning them a day/time rather than relying on them to sign up. For the most part this has worked well ... and it has reconnected some people, allowing us to see familiar faces in the building again. Assigning people may not seem to allow for new people to join in helping with the various ministries, but everyone is always welcome, at any time ... just let us know and we'll get you signed up!

During the LaCrosse Area Synod Assembly, I was elected to a three-year term as Dean of our West Conference clergy. The West Conference includes 13 congregations and 3 synod ministries – Eagle Crest Communities, Lutheran Campus Ministry, and St. Croix Hospice. That means keeping the schedule of our monthly meetings and sending out reminders; and chairing the Pre-Assembly Caucus for our conference. The Dean's meet monthly to share what's going on with the pastors and congregations in each of our four conferences. As Dean, I am also a member of the Synod Council – like a congregation council, but the governing body for the whole synod. This means more meetings, but I am also "in the know" on what's going on in the synod.

I continue to serve as one of four community members on the Institutional Review Board (IRB) at Gundersen Health Systems. During the pandemic we would meet virtually, as the hospital limited who was in the building. As things have evolved, meeting virtually has continued to be a good option, especially in those months when there is limited business on the agenda, and driving downtown would take more time than the actual meeting. This committee has allowed me to keep my finger in the healthcare "pot" that had been so much a part of my life previously.

As activities and events in the schools opened back up, we were once again able to be out in the community. They welcomed back the Scholastic Book Fair in the spring, and volunteering for that is always a fun time for us being able to see so many of our elementary kids. We get a warm, fuzzy feeling as the kids' eyes light up when they see

us and yell "Hi Pastor Jon! ... Hi Pastor Jean!" As a judge for the High School Senior Exit Project (SEP) event, it was nice to be back in the building again. That is a learning time for me as these young adults come up with some excellent projects and share about them. And, we even got to attend several home football games this fall ... good to see so many of our families supporting the team, and so many of our young people playing! Doesn't hurt that we both love to watch the game, too!

2022 was a year to begin transitioning back to more familiar, comfortable ways of doing ministry. We have learned to be more flexible, discovered that some new ways of doing things have advantages, appreciated some of the "old" ways, and look forward to seeing where ministry goes in the year to come. We are learning to live with having Covid, other variants, and more significant flu's as a regular part of life ... and making adjustments to get things accomplished. Despite doing everything possible to stay healthy, no one is immune from getting sick ... including us ... and there are lingering side-affects that we have to work through.

As we look to ministry in 2023 so many ideas are swirling around ... restarting home communion ministry ... having homemade bread for communion ... getting the Senior Ministry Team back together and planning OWLs events ... getting the Mom's Group back together for support and fellowship ... starting small group discussions on various topics (got any ideas?) ... having more intentionality connecting with our college students ...

For those who are new to Our Savior's during the past couple of years, for those who have been away for a while and are re-connecting, for those who have been around forever and are looking for something new to get involved with ... we have a place for you! MINISTRIES

Worship Helpers – As fall came, we finally felt comfortable stepping out and trying to get back to some sense of "normalcy". To that end, we started scheduling people to once again help with worship – acolytes, communion assistants, and ushers. In the process we have "rebranded" some of the jobs to better reflect the ministry that is taking place. Our ushers are now the Welcoming Team, putting the emphasis on greeting and welcoming all who come through our doors. The acolytes continue to light/extinguish the candles, but they are now also helping to serve communion rather than collecting empty cups; so, they are now considered Worship Assistants. The Communion Assistants continue to be a vital part of the Lord's Supper, preparing and serving Communion. It is good to have the people of God sharing their gifts during worship.

Home Communion Ministry – Delivering communion and visiting our shut-ins has always been an important ministry at Our Savior's and we have missed that these last years – our shut-ins miss the visits and those who would do the visiting have missed seeing "their people". This ministry is in the process of being re-started and will begin again in February 2023. We all look forward to reconnecting with our homebound members.

Altar Guild – For the last two+ years, I have been the Altar Guild, along with Pastor Jon and Kris – filling the candles, changing paraments and banners, preparing for communion. I am excited that starting in the fall, we have been able to reengage this faithful group and they are now back providing this ministry for our congregation. We try to have teams of two, serving for one month at a time, and depending on how many teams we have, most serve about two times a year. Others are always welcome to join us – *the more the merrier!*

Prayer Ministry – Our prayer ministry is probably one of the only things that never missed a beat throughout the pandemic years. Because we communicate via email, the prayer petitions were always sent, and those receiving them were able to pray wherever they were. We all know how important prayer is and how it impacts ours and others' lives. We are grateful to this faithful group of pray-ers who work on behalf of the community gathered here. We welcome others to join us ... in the comfort of your own home, on your own schedule, doing God's work.

Senior Ministry – The "obvious" part of senior ministry may not have been happening in recent years, as gathering together for fellowship has not been an option, but ministry to our seniors has continued. We thank Carolyn Karl for faithfully delivering DVD's of the worship service to several of our shut-ins every week. Birthday and holiday greeting cards have continued to be sent to our "over 80" crowd, letting them know they are never far from our thoughts. With the resumption of in-person Sunday School, our classroom grandparents are once again receiving greetings from "their" kids! The Pastors have been able to return to Lakeview, Salem Terrace, and Mulder's for monthly worship services. As we head into the new year, we are hopeful to get our team together again and plan activities for our "Older, Wiser Lutherans" (OWLs) ... and maybe even get back in to Salem Terrace for our monthly "study" and fellowship. If you would like to be a part of the Senior Ministry Team, let Pastor Jean know.

College Ministry – Keeping connected with our college students has been a challenge in recent times. It feels like we have lost track of so many of them ... are they still in school ... what year are they now ... are they living at home or on campus?? Too many questions and not enough answers. Late in the year we tried once again to be intentional about remembering our students at semester exam time with a note and gift card, but that too was a challenge not having many addresses/contact information. We want our young people to know they are an important part of this church community and that we are thinking about them and missing them while they are away. Hopefully in the new year we can continue to reconnect with more of our young people.

Vacation Bible School – Based on the lack of participation and interest in VBS in 2021, we have chosen to suspend that at this time. Perhaps VBS no longer fills a need/purpose for our children. We are open to re-evaluating this decision in the future and will gladly host a time to gather if the interest presents itself. An alternate idea may be to plan a Day Camp experience at Sugar Creek?

Sunday School -

After being virtual and hybrid for two years, we were excited to be back together this fall for Sunday School. It was great to be able to interact with the children and see their smiling faces. They are full of enthusiasm and energy and bring life to us and to this place. We returned to using the *Whirl* lectionary-based curriculum from 1517 Media and having video time with Pastor Jean, along with the lesson with our teachers. In the absence of enough teachers, we ended up combining several classes. The curriculum is designed to make that work well. We also didn't have a music leader in the fall, but were able to make things work so there was music for the Christmas program. The lack of a Sunday morning routine during the pandemic seems to have taken a bit of a toll on Sunday School attendance, but we are hopeful as things continue to get back to "normal", we will also see our kids more regularly. We really did miss them and very much appreciate our time together.

The Sunday School Christmas program, "Be Born in Us Today", was held during the 10:30 AM worship service on Sunday, December 11th. The kids worked hard for many weeks preparing for the program and they did a great job! We are grateful to our teachers, musicians, and helpers for making this possible, and to our parents for getting the kids to practice each week ... which was sometimes a challenge as flu bugs continue to run rampant. The congregation seemed to enjoy being a part of this program once again.

We continue to gift our children with their first *Frolic Bible* at the time of their baptism, and our PreK children once again received their *Whirl Story Bible* in worship this fall. Pastor Jon was particularly excited to be able to have the Bible Workshop in person with our 3rd grade children and their parents, and then to present the Bibles during worship.

Audit Committee

The Audit Committee's ministry is to provide reasonable assurances that good stewardship is being used in handling and accounting for the funds and other assets of Our Savior's Lutheran Church. Members of the 2022 Audit Committee were Dori Jensen, Jeff Haldeman, and Jim Anderson. The committee met seven times and completed an audit of the church's accounts and financial practices. In conducting the audit, the committee reviewed selected months of the General Fund Account, the WELCA Account, the Quilting Account, and the Youth Account. The committee also reviewed procedures for handling, counting, and depositing offerings, as well as payroll procedures; procedures for accounts payable and payments to vendors; IT access and backup procedures; and Scrip card and Youth Account procedures.

The committee found that procedures and internal controls in place are generally adequate to protect the church's finances and only a handful of minor procedural changes were recommended to the Council for their consideration. There were no account irregularities identified.

Confirmation Youth

After a tough year in 2021, 2022 was a bit more "normal" for confirmation youth and the ministry we carry out with them. Confirmation classes were all in person, though a bout with Covid in October forced Pastor Jon to record a class and let the kids watch on YouTube. In addition, many of the core classes either were, or already are, recorded, ensuring that students have access to the classes, even when they are forced to miss a class.

One "gain" from the pandemic experience was the "outdoor gathering." We gather in the prayer labyrinth lot, with a fire in the fire pit and some goodies to share, and have time to connect, or even carry out a class. Started as a temporary effort to get the kids together, we discovered it was well received – and we plan to make regular use of that opportunity in the future.

An important component of the confirmation ministry, "small groups," was not brought back due to a lack of small group leaders. We miss that, and hope that perhaps in a future year we can move back to small groups. Way too much benefit to let that go too easily!

On the other hand, another important component, "servant leadership," has continued to thrive and grow. Becky Murphy teaches 7th/8th graders the concepts behind "servant leadership" in two sessions each year, and 9th graders are challenged to imagine how they might be servant leaders in the future. In addition, late in 2022 conversations began with Rachel Holthaus to engage her as our new "Director of Youth Ministry" with an emphasis on servant leadership development among confirmation and post-confirmation age youth. We will be excited to see that grow in the coming years.

Throughout our programming, from 6th-9th grade, we are always seeking ways to make the connection between learning in the classroom and living in the world. We also welcome and encourage new participants on the journey (new students!) and new partners in the ministry (new ways for adults to share their witness!).

We thank all the adults who are a part of the work we do together, including the parents who share the meal with the After-School crowd, and those who join us in the classroom, either as parent helpers or leading an elective course. A special thanks to Corey Sjoquist for his continued faithfulness in working with the 6th graders as he starts them off with a solid Biblical grounding.

Lutheran World Relief School Kits & Personal Care Kits

The congregation supported three Lutheran World Relief (LWR) projects in 2022. We continued our annual support of the LWR Quilt and LWR School Kit projects and initiated first-year support for an LWR Personal Care Kit project.

The LWR Personal Care Kit project was initiated as a Lenten challenge by youth director Wendy Amundson. This project offered an opportunity for families to purchase and individually assemble a care kit that would in turn provide basic hygiene necessities for a family or individual displaced by natural disaster, poverty, war, or economic situation. The kit consisted of a bath towel, two bars of soap, toothbrush, comb, and nail clipper. A total of 210 personal care kits were assembled by individual families and by the Wednesday "after school" confirmation student volunteers who assisted with the final assembly of 120 of that total number.

The annual LWR School Kit project was reactivated by our office secretary, Kris Seeger, in time for summertime purchases following the youth director position vacancy. School supply sale prices were not as generous nor as numerous in 2022 as supply shortages, inflationary price increases, and the pandemic all impacted supplies. We were able to complete 101 kits, though that was a decrease from last year. WELCA again provided the school kit bags through a donation from Thrivent allowing us to purchase additional supplies. The Wednesday "after school" confirmation student volunteers completed 100% of the unpacking, sorting, counting, and bundling (pens & pencils) of all supplies, and the final building of 50 kits. After a two-year pandemic interruption, the combined third and fourth grade Sunday School class of Ms. Stefferud and Ms. Sjoquist were again able to assist with the packing of 51 kits.

All LWR donations were boxed and transported to Good Shepherd Lutheran Church in La Crosse on October 9th. From there they were to be trucked to the LWR warehouse in South St. Paul, MN, for redistribution, probably in 2023. The 37 boxes of quilts, 17 boxes of care kits, and 10 boxes of school kits were loaded and transported by Carolyn Karl, Carla Burkhardt, Eric Sorenson, and Josh Corning. All boxes had tracking tags that will allow us to find out the final destination of each item. Tracking tags from our October 2021 shipment indicate that our donated school kits were shipped to Syria and Jordan, and the quilts went to Peru. Both warehouse shipments were completed in March 2022. In previous years quilts and school kits had gone to Lebanon, Rwanda, Georgia (the country), the Bahamas, and Honduras.

Thank you to everyone who helped make these projects a success. Somewhere the lives of 611 families/individuals have been supported by your generosity (300 quilts + 210 care kits + 101 school kits = 611 donations). We look forward to the continuation of these projects in 2023.

Of course, Kris in the office, Pastors Jon & Jean, and Josh helped us regularly as they were here with us in the building, cleaning up, taking calls, etc. Judy Long would check in on us on behalf of the Food Pantry. Erin at Wafer made a couple of contacts with extras that we were able to serve. There are really so many who donated items and volunteered, this truly is a community partnership and huge group effort.

I would like to point out Carla Burkhardt, who took the lead on delivery options when, with less than a week to prepare, school funding changed to allow lunches to be free for all during summer school!!!!!!! Kids on our delivery list got two meals every day for those 3 weeks!

By the end - we were serving just under 200 children daily. Some days we were even able to toss in a few healthy snack/breakfast items for the next day. Compeer Financial (with the lead of Tracy Skrentny) provided meal packs that we were able to include with all of our deliveries, as well as families in need who utilize the BGC.

I want to thank you all for your help and participation. The use of this space and the support of our congregation is how this is possible.

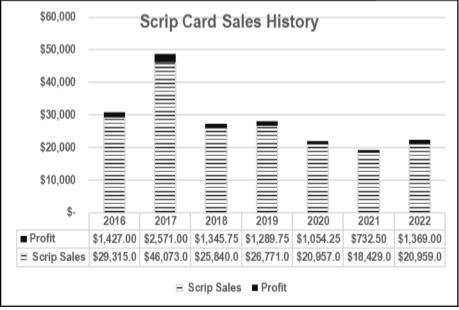
