

## T.C.H.A. Minutes April 6, 2015

The meeting was called to order by President, Nancie. The Secretary's report was read, Debbie made a motion to approve the minutes, Donna 2<sup>nd</sup> the motion, the minutes were approved. The Treasurer's report was not given due to treasurer's absence. Debbie turned in \$ from the stall fees. Nancie recouped the money from a check that was returned from last show season. Nancie checked into ordering free items from Cowboy Magic but the shipping cost would be more than purchasing the items locally so decided not to order them.

Sharon gave a reminder to vote yes on the millage for 4-H election in in May.

Discussion was started about show ribbons. Jerry made a motion to order the solid rosette ribbons for our TCHA shows, Sharon 2<sup>nd</sup> the motion the motion was passed to order the smaller rosette ribbons of solid color for the TCHA shows.

The show budget for 2015 was discussed and questions were raised on how we could generate funds for our club. Nancie suggested to raise the office fees from \$1.00 to \$2.00. This money would go directly to TCHA. Andrea made a motion to raise the office fees up to \$2.00, Carrie 2<sup>nd</sup> the motion the motion was voted on and passed. Discussion was made on raising the membership for late registration. However the information was already on the website. A motion was made by Jerry and 2<sup>nd</sup> by Sharon to keep the membership fees the same for this year and possibly raising them for next year. This will be discussed later for 2016.

A tack sale was discussed for May 16<sup>th</sup>, but because of many conflicts this was tabled for now.

A fund raiser on June 13<sup>th</sup> was discussed for TCHA for bagging groceries at Super One foods. Jeff made a motion to have the fund raiser, Carrie 2<sup>nd</sup> the motion, motion was voted on and passed. We will need youth and parent volunteers for

this. Tammy and Liz are heading up the calling and organizing this event. Please volunteer we need the extra funds.

A new logo sign was donated to our club by Excell Graphic. Thank you Nancie for your help in acquiring the new sign. We can use it at our shows and fund raising events.

TCHA apparel, hats and window stickers were discussed. Andrea will take orders for shirts, hoodies and hats if anyone is interested talk to her. Nancie is looking into window clings and vinyls for trailers.

Jackpot barrels were discussed and will be open to the group hosting the show if they decide to have them or not.

May 9<sup>th</sup> is the Silver Spurs Spring Clinic and they generously donated a booth to us to promote our club. Andrea and Jeff will represent our club at the event. Nancie is looking in to having flyers made to use at the event.

Jerry made a motion to adjourn the meeting, Dale 2<sup>nd</sup> the motion, meeting was adjourned. May 4<sup>th</sup> is our next meeting.
